### WAIVER, POLICIES AND PROCEDURES 2017-2018

#### ALL:

\_\_\_\_\_ I hereby waive Cincinnati Baila! Dance Academy (CB) and its duly authorized agents, servants or staff of all responsibility in the event of any type of injury, health condition, or physical problem that my son/daughter may already have or receives as a participant at any CB activity or event. Please note injuries can be severe in nature including, but not limited to broken bones, torn ligaments, paralysis and even death. I certify that my son/daughter has no health or physical defects that may hamper his/her ability to perform at any event, practice or performance that might cause dance/ tumbling to be unsafe to his/her health. Furthermore, CB is not liable in any way for any travel injuries to and from practices, performances or any activities associated with CB. I acknowledge that I have been properly advised, cautioned and warned by owners, coaching staff and other personnel that by participation in the sport of dance, including practice, competitions and shows, I am exposing my son/daughter to the risk of serious injuries including but not limited to sprains, fractures, and ligament and/or cartilage damage which could result in temporary or permanent, partial or complete impairment in the use of limbs, brain damage, paralysis, or even death. Having been cautioned and warned, it is still my desire to allow my son/daughter participation in the sport. I further acknowledge that I do so with full knowledge and understanding of the risk to which I am exposing my son/daughter by participating in the above team.

#### Minor Liability Release

\_\_\_\_\_ I the parent and or/ legal guardian of the child/children listed in my account, understand the nature of these activities and that the minor(s) to be qualified, in good health, and in proper physical condition to participate in such activity. I hereby release, discharge covenant not to sue, and agree to indemnify and save and hold harmless each of the releasee's from liability claims, losses, or damages on the minors account, including negligent rescue operations. I further agree that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claim against any of the releasee's named above, I will indemnify, save, and hold harmless each of the releasee's from any litigation expenses, attorney fees, loss liability, damage, or cost any may incur as the result of any such claim

\_\_\_\_\_ I acknowledge that **athletic injuries** do occur and can be costly. My son/daughter is covered by adequate health insurance to cover any cost of accident or injury that might occur to him/her during any CB event, practice or performance. CB cannot and will not accept any financial responsibility for any athletic injury. Any injury will require a doctor's signed release form before returning to dance.

\_\_\_\_\_ I give consent for my child to receive emergency medical care and to be **transported** in ambulance or other conveyance to a doctor or hospital for attention and treatment.

\_\_\_\_\_ I hereby release any **photos** and/or video of my son/daughter that may be taken during any of CB events, practices or performances. I understand that these photos and /or videos will be in good taste and may be on social media as well as traditional advertising vehicles.

\_\_\_\_ I have read and understand all the aforementioned points. I give my son/daughter my permission to **participate** in the events, practices and performances.

\_\_\_\_ I understand that I have to **stay inside Cincinnati Baila!** at all times, and CB is not responsible for taking care of my kid after or before his/her class.

\_\_\_\_ Tuition is **due** the 1<sup>st</sup> of the month, September through May. These payments are due regardless of the number of weeks and/or classes in each month. There is a late payment fee of \$10 for any tuition that is not paid in full by the 10<sup>th</sup>. I understand that payments are binding and my dancer may be removed from the performance team if I am not current in tuition payments.

\_\_\_\_ In the case of **cancelled classes** due to unforeseen circumstances including but not limited to weather (i.e. snow emergency), CB has created an annual class schedule which allows for one cancellation. Therefore, in the event of a second class being cancelled due to unforeseen circumstances, CB will provide a makeup session which will not necessarily be at the same time as the current class. CB does not pro-rate tuition based on cancelled classes.

\_\_\_\_ Dancers will enter the classroom, ready for class: **proper dance outfit**. Boys or Girls may wear tucked in T-shirts and shorts OR Leotards for Girls. NO chewing gum or dangling jewelry. Hair should be pulled neatly and securely away from the face so that it stays up for the entire workout. Girls should not wear bows or other large hair ornaments that may cause discomfort during activity. Having used the restroom, and carrying their personal water bottle; they will bring each class their training skirt and dance shoes. Personal items should be left in cubby holes. Jewelry should not be worn during classes. This facility's staff will not be responsible for ANY items that may be lost or stolen. Be sure your student's personal items are marked with their name.
